**Employment Training Panel Approves \$7.5 Million
to Train 11,800 Workers**

*Andrew Furuseth School of Seamanship to Receive \$55,000 to Train 37 Workers
in the Maritime Industry*

SACRAMENTO – The State of California’s Employment Training Panel announced today it approved 35 contracts worth \$7.5 million to train 11,800 workers. In one contract, the panel awarded \$54,593 to Andrew Furuseth School of Seamanship to help train 37 workers in the maritime industry.

“Employment Training Panel job training funds assist workers in enhancing their skills to meet the needs of vital industries,” said Stewart Knox, the Employment Training Panel’s executive director.

The Andrew Furuseth School of Seamanship, located at the Sailors’ Union of the Pacific headquarters building in San Francisco, was founded in 1942. Trainees of the school crew commercial ships, tugs and barges engaged in maritime transport. Typical duties include bridge watch-standing, shipboard and shore side maintenance, emergency response on deck or in the engine areas, and stewarding onboard.

“The Andrew Furuseth School of Seamanship will use the Employment Training Panel contract award to train young adults and veterans from the East Bay area and the Long Beach/Wilmington area for jobs that provide good wages and benefits, as well as an opportunity to see the world from the deck of a US Merchant Marine vessel,” said Berit Eriksson, Andrew Furuseth School of Seamanship training director.

Training will include the operation of vessels for the transportation of freight and passengers on the deep seas, primarily out of California ports in San Francisco, Oakland, Alameda, San Pedro and Long Beach. Goods from these ports reach foreign ports all over the world, including the Pacific Rim and the Middle East, domestic ports in Hawaii and other Pacific Coast locations.

The Panel’s approved proposal will also provide training certified by the US Coast Guard and approved by the International Maritime Organization. The proposed training will support the training of tankermen, ordinary seaman and able-bodied seaman on a variety of basic mariner skills and safety training.

The Employment Training Panel is the state’s premier program supporting job creation and retention through training. The panel reimburses employers for the costs of training existing

workers, funds training for unemployed workers to re-enter the workforce and helps to ensure California businesses have the skilled workers they need to remain competitive.
